


# What costs are eligible for network projects and innovation projects?


- Costs for staff and outside personnel services

The programme CIR-CE offers a framework for transnational networks organised by intermediary organisations (such as competence centres, technology centres, clusters) to encourage transnational projects covering R&D, technology transfer, benchmarking, quality assurance etc.

Enterprises, intermediaries and research institutes are likewise addressed. Take a look at the required partner structures below, find your partners and take the challenge!

CIR-CE is a strategic core activity of the Austrian Federal Ministry of Economics and Labour. The Austrian Research Promotion Agency (FFG) is responsible for the programme management and offers guidance for prospective applicants and partners.

## Objectives of CIR-CE projects

Establishment and expansion of transnational, business-driven innovation networks (particularly SME) between Austria and CEE countries for the development and implementation of innovation and for increasing and strengthening R&D cooperation and technology transfer.

- Contribution of project towards programme objectives

- Impulse centres
- Company clusters
- Competence centres
- Cooperative research institutions
- Research organisations fulfilling the function of intermediary institutions (focus on technology and knowledge transfer)
- · Companies as network coordinators
